Meeting of the Marion City Council Monday, June 15, 2020-5 p.m.

The Marion City Council met in Regular Session June 15, 2020 at 5:00 p.m. with Mayor Jared Byford presiding. Council members present: Phyllis Sykes, Donnie Arflack, Dwight Sherer, D'Anna Browning, and Mike Byford. Council member Darrin Tabor was absent. City employees in attendance were as follows: Adam Ledford, Layten Croft, Pam Enoch, and Chief Ray O'Neal. A public sign-in sheet is attached and made part of these minutes.

GENERAL GOVERNMENT

Motion by Phyllis Sykes, seconded by D'Anna Browning to approve the March 16, March 26, May 21, and May 28, 2020 meetings minutes same as submitted to the council. All voted yes.

Motion by Donnie Arflack, second by Dwight Sherer to adopt resolution #20-01, entitled, "Resolution of the City of Marion, Kentucky in Support of the Marion Police Department and a Continued Commitment to Combating Crime". All voted yes. A copy of said resolution is attached and made part of these minutes.

Councilmember Mike Byford introduced Ordinance #20-10, entitled, "Amending Marion Code of Ordinances". Administrator Ledford gave the first reading of said ordinance.

Administrator Ledford updated the council on the following projects:

- (1) Sewer Line Paving Project- Ledford stated that Rogers Group got started a week ahead of schedule on paving, and approximately a dozen of roads got paved, and they still have to finish Country Club Drive. Due to Leland Avenue's drainage issue, it has still not been paved. Council member Donnie Arflack said it was best to fix it correctly before paving, he then suggested that Shelby Belt take a backhoe to take up the part of road that needs fixing. Paul Beard explained his concern on fixing Leland Avenue.
- (2) Sidewalk Project- Ledford advised the main contractor is waiting on the green light to say move forward, he explained that we should start seeing progress any day.
- (3) Sewer Plant Project-Ledford advised bidding should be opened anytime and that he and Alan are working on a 12 month extension due to the COVID-19.

Administrator Ledford updated the council on the E911 meeting from the previous week between the city and county. Ledford explained the two different paths that were discussed. One option discussed being, the creation of a board, consisting of seven members; four members being law enforcement and three members being elective bodies. Ledford added that the committee would be looking at other counties and seeing how they operate with a joint board. The second option being discussed is, out sourcing dispatch to the Kentucky State Police. He added this would mean that a dispatcher sitting at KSP near Madisonville would be responsible for answering and dispatching 911 calls originating in Crittenden County.

OTHER BUSINESS

Council member Phyllis Sykes advised she was glad to see the minutes from the Marion Tourism Commission.

Council member Donnie Arflack inquired about the fire hydrant list. Administrator Ledford stated he had the list sitting on his desk.

Council member Dwight Sherer requested someone to pick up trash at Lake George.

Council member D'Anna Browning inquired about getting Lake George re-stocked with fish.

Council member D'Anna Browning asked if Watson Street had been paved.

Council member Mike Byford asked who was doing Code Enforcement now. Police Chief O'Neal advised that Officer Heath Martin started around three weeks ago.
